Agenda

Councilwoman Jackson asked to add Council Attorney Mike Gillenwater's contract to the agenda. Mayor Hodges asked to add Election of Council President on the agenda.

Councilwoman Jackson made a motion to approve the two additions to the Council agenda, seconded by Councilman Hester. Approved 5-0.

Ordinance 2022-OR-01

Mayor Hodges said this appropriation ordinance allows for new carpet in City Hall. The carpet is in bad shape and is worn. It is creating a tripping hazard downstairs and could cause someone to fall. The cost to replace the carpet is \$91,700.00 to for the carpet upstairs and downstairs.

Councilwoman Jackson made a motion to approve Ordinance 2022-OR-01 on the second and final reading. Approved 5-0.

Council Attorney Contract

Councilwoman Jackson presented the attorney contract for Mike Gillenwater. There is no changes in the contract. The city will offer him and his wife medical insurance at Mr. Gillenwater's expense.

Councilwoman Jackson made a motion to approve the legal contract for the council attorney, seconded by Councilman Hester. Approved 5-0.

Common Council President Election

Councilman Hester made a motion to elect Councilwoman Jackson as President of the Council seconded by Councilman Steele. Approved 5-0.

Council Meetings

Mayor Hodges asked if Monday meetings at 6:30 p.m. were good for everyone. Councilman Hester said he may have high school baseball conference games in April and May. He should know within a week or two. The Council voted to approve the meeting date. Approved 5-0.
