Re: 2024 Budget Draft Presentation

Dear Council Members:

The purpose of this memo is to present the city's proposed 2024 Budget Draft for your review with anticipated first reading and public hearing to be held on Wednesday, September 6 at 6:30 PM and a second and final reading at the regular October Council meeting. The budget draft reflects a 3% cost of living increase for all city employees and elected officials. It also shows a 25% increase in health insurance allocation, and in costs associated with property and casualty insurance. Anticipated surplus funds from our levy increase will be allocated in the Council Miscellaneous fund.

Please review this proposed budget and send feedback or questions to me and/or Donna Coomer by Thursday, August 31st. Our 2024 budget must be fully adopted by November 1. I anticipate having the public hearing and first reading at the Council's September meeting and the second and final reading at the regular October meeting to meet our deadlines.
