ORDINANCE NO. 2000-OR-16 AN ORDINANCE ANNEXING TERRITORY IN THE INDIANA ARMY AMMUNITION PLANT ADJACENT TO THE CITY OF CHARLESTOWN

WHEREAS, the municipal boundary of the City of Charlestown, Indiana, is adjacent to the real estate described in "Exhibit A", which is attached hereto and incorporated by reference herein; and

WHEREAS, the future growth of the City of Charlestown depends in large part upon the successful development of the property commonly known as the *Charlestown Army Ammunition Plant* or the *Indiana Army Ammunition Plant*, which territory is needed and can be used by the City of Charlestown, Indiana for its development in the reasonably near future; and

WHEREAS, the City of Charlestown is the only City or Town in Clark County which is contiguous to the territory to be annexed and, more than any other local municipal body, the City of Charlestown has the authority and is in a position to provide the regulatory leadership to facilitate the successful development of the property being annexed; and

WHEREAS, the Common Council of the City of Charlestown has previously adopted a fiscal plan to provide City services to the proposed annexed area; and

WHEREAS, the proposed area to be annexed has a boundary that is at least 25% contigous with the existing municipal boundaries of the City of Charlestown; and

WHEREAS, the Common Council of the City of Charlestown has previously been presented with an ordinance for the annexation of the area described in "Exhibit A",

NOW, THEREFORE, Be it ordained by the Common Council of the city of Charlestown, Indiana, as follows:

- 1) The real estate described in "Exhibit A", which is attached hereto and incorporated by reference herein, is hereby annexed and declared a part of the City of Charlestown, Indiana, and is assigned to the fourth councilmanic district.
- 2) The boundaries of the City of Charlestown shall be, and hereby are declared to be extended so as to include all of said real estate as a part of the City of Charlestown.
- 3) This ordinance shall be in full force and effect from and after its proper passage, publication and recording according to law.
